1. ANNOUNCEMENT:

The Quad Riders Association of South Australia Inc hereafter called the PROMOTER will conduct Mannum 2 Day Enduro on the 12th & 13th of August 2017 for ATV Senior Ironman and Teams. Mannum 2 Day Enduro is located on the Haby's private property on Herbig Road, Mannum. This property is located on the Sedan Road to the east.

2. JURISDICTION:

- 2.1. The abovementioned meeting has been authorised by Motorcycling SA Inc which has issued the Motorcycling Australia Permit Number [INSERT PERMIT NUMBER] and is open to holders of current Motorcycling Australia Senior & Junior National Licences, Club and one event competition Licences.
- The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, 2.2. and any final instructions approved by Motorcycling SA Inc.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES. REGULATIONS, BY-LAWS AND INSTRUCTIONS.

ENTRIES: 3.

- Entries open forthwith and close last mail on the Thursday 10th August prior to the event. 3.1.
- In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by Quadriders 3.2. Association of South Australia Inc. if such retention is approved by Motorcycling SA Inc.
- Only entries received on the official entry form that is accompanied by the correct fee will be accepted. 3.3.
- NOTE:- LATE ENTRIES MAY BE ACCEPTED WITH A LATE ENTRIE FEE OF \$10, AND THE RETURN OF ENTRY FEES FOR 3.4. ANY RIDER WITHDRAWING FROM THE MEETING ARE AT THE DISCRETION OF QUADRIDERS ASSOCIATION OF SOUTH AUSTRALIA INC.

INSURANCE: 4.

- 4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2. Ambulance Insurance is compulsory for licensees.

8 CLASSES OF COMPETITION

Enduro: Senior ATV Ironman Up to 930cc (IRONMAN), Senior ATV Teams Up to 930cc (TEAMS).

NB: Minimum 5 entries required to constitute a class (point 10 below)

9 AWARDS AND PRIZEMONEY:

A presentation announcement will be made for 1st, 2nd, and 3rd place in each competition class.

Points will be tallied at the end of the Series and trophies will be awarded to 1st, 2nd and 3rd for all competition classes

10 ENTRIES TO CONSTITUTE A CLASS:

- 10.1. To constitute a class, the number of contestants entered and competing in each class shall be five (5)
- 10.2. Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards and / or prizemoney, will be at the discretion of the Quadriders Association of South Australia Inc, subject to Motorcycling SA Inc. approval.

11 RACE FORMAT:

For each race, competitors will start 15 to 60 seconds apart as determined by hat draw. Racing Cross Country generally on Sand, Limestone Rock and Scrub environment with both natural and formed obstacles. Competitors MUST follow marked course. Senior Event will be over 2 days, racing a 2 hour timed heats both days. The race ends when each rider crosses the finish line after the nominated race duration. Outright and Class finishing positions will be determined by total of 35 point system scores with any necessary decider determined by number of full completed laps and fastest total time taken. Any cutting of course or riding on any crop will result in rider disqualification. Officials will be moving around the course wearing high visibility vests identified to entrants during riders briefing.

12 MACHINES AND RIDERS:

- 12.1. All machines entered must comply with the current GCRs for ATV Enduro competition.
- 12.2. Changes of machine is permitted providing the substitute machine has passed scrutineering.
- 12.3 To participate in the event, it is the rider's responsibility to present their machine at the designated scrutineering point and pass scrutineering for Competition.
- 12.4 Riders must display numberplates on their machine which comply with the 2017 GCR's
- 12.5 To compete, all riders must have clearly visible numbers on his or her back that comply with the 2017 GCR's. NO BACK NUMBERS may mean NO POINTS.
- 12.6 See QuadridersSA website http://www.guadriderssa.com.au/Enduro-s/ for 39 Club Enduro Series General Rules.

13 GRID POSITIONS:

Enduro: Start order will be determined by hat draw at riders briefing.

14 RIDERS' BRIEFING:

Riders Brief for Enduro will be 15 minutes before sighting lap, which ALL competitors MUST attend. Riders may be required to sign to say they have attended riders briefing. Details will be included in the final instructions.

14.1 PRACTICE: A lead non-compulsory sighting lap of your full race track will be offered prior to race start.

15 DRUG AND OR ALCOHOL TESTING:

- 15.1 All competitors and officials are advised that as part of the MA and MSA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency and the Motorcycling SA Drug and Alcohol Policy.
- 15.2 If any doubts exist over banned substances it is recommended competitors contact the Drugs in Sport Hotline, tel 1800 020 506. When drug testing takes place, the payment of prizemoney may be delayed at the Motorcycling SA Inc. discretion until the results of the tests are known.
- For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed to be at the start of sign-in with the completion of the meeting for the participant being when the participant has vacated the venue.

16 CODE OF CONDUCT:

All competitors, officials and parents are reminded of the Motorcycling Australia by-law - CODE OF CONDUCT (as stipulated in the GCRs), which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

18 CIRCUIT DESCRIPTION:

Enduro: The race courses consist of varying natural terrain areas with established tracks through scrub vegetation and some formed obstacles.

19 STARTS:

ENDURO: Individual flagged starts at 15-60 sec intervals (determined by officials on the day).

20 NOISE

- 21.1 Noise emissions levels have been changed: with the 2m max method, the limit is 112 with a 4dB(a) allowance
- 21.2 Competitors may be required to undergo a static noise test during the event.
- 21.3 No person may complete in any event on a machine whose emissions exceed the limits as noted in GCRs.
- 21.4 If a machine fails it can be presented for re-testing several times.

21 GST:

The Goods and Services Tax affects the payment of prizemoney. If you do not provide an ABN or declare the sport is a hobby, the Promoter must withhold 48.5% of prize money over \$75.00 which is otherwise payable to you. Please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount of prize money is paid to you.

22 SPECIAL NOTES AND WARNINGS:

- 23.1 NO tear offs are allowed in any events.
- All refuelling must be done with engine off. It is encouraged to have a fire extinguisher present when re fuelling any vehicle. Environmental mats 500mm long and at least 400mm wide must be placed under all motorcycles whilst refuelling or changing oils. Carpet or any material not made for the absorption of petroleum products is not allowed to be used.

 NB: A limited number of Environmental Mats will be available for purchase from the club during sign-in for \$5 each.
- 23.3 Helmets must be worn at all times whilst on any motorcycle. This includes unloading, loading and scrutineering etc.
- 23.4 Riding in the pits must be at walking pace. Any rider who disobeys a warning may be excluded from racing and a \$50.00 fine may be Imposed.
- 23.5 Smoking and Alcohol prohibited in pit areas
- 23.6 With the exception of Guide dogs, **no dogs are permitted** on the grounds at any time.
- 23.7 Closed shoes must be worn in the pit at all times.
- 23.8 Fuel testing may be carried out at any time during any round of the series.
- 23.9 Presentation will be held Sunday after racing.
- 23.10 NO CANTEEN AVAILABLE
- 24. No Hassle Policy: Any rider, entrant or person associated with a rider or entrant shall conduct themselves in an orderly manner in any dealings whatsoever, with any official of the meeting. A rider shall be responsible for his/her own conduct and that of any person with whom he/she is associated who abuses or threatens in any manner, either verbally or physically, any official. Penalties, which may be imposed by the stewards for breach, include reprimand or warning. Minimum \$50.00 fine or exclusion from the meeting.
- 24.1. Abandonment: In the event of the meeting being abandoned due to circumstances beyond the control of the promoters before racing Commences, entry fees will be returned, less a fee per entry to cover administration costs. Once the competition has commenced only the stewards of the meeting have the authority to abandon the meeting and their decision shall be final. In such cases the stewards will rule on the results according to the circumstances.
- 24.6. Bicycles: Bicycles are not permitted in the pits or on the racing circuit during racing.
- 24.7. Motorcycles: Are to be kept in the pit area at all times when not being used for competition. Unless permission to remove the motorcycle has been granted by the stewards of the meeting. Any motorcycle removed from the pit area without permission of the stewards, will be deemed to have withdrawn from the competition.
- 24.8. Reservations: The Stewards of the meeting reserve the right to alter, postpone or cancel all or part of the events program.
- 24.9. Unauthorised: Persons are prohibited from entering the track infield area. Such unauthorised persons will be removed from prohibited areas.

24.11. Property Details/Directions:

- Any cutting of course or riding on farmers cropped areas will result in rider disqualification.
- Take home all rubbish, (some camping areas will have drums only for cans and bottles),
- No fires on fire ban days,
- Bring your own fire wood,
- **All efforts are made to keep this property safe and enjoyable for all, however all riders and campers are there at their own risk**
- Showers available with a gold coin donation.
- It is advised that all riders carry a UHF on them during this event.

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

DEFINITIONS

- In this declaration:
 "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
- "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
- "MA" means Motorcycling Australia Limited;
 "State Controlling Body" (SCB) means a state or territory
 motorcycling association affiliated as a member of MA;
- "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity; "Motorcycling Organisation" means and includes MA,
- and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

- I ACKNOWLEDGE that:
- motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as
- that I may be injured, physically or mentally, and may be killed:
- that my machinery or equipment may be damaged, lost or destroved:
- that competitors may ride dangerously or with a lack of skill;
- that track or event conditions may be hazardous and may vary without warning or predictability; that organisers, officials, landowners/track operators and any
- agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events; that any policy of insurance of or in respect of my life or
- physical or mental health may be voided; that there may be no or inadequate facilities for treatment or transport of me if I am injured;
- vii) that I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
- the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
- to the extent that any warranty is implied it is excluded to the full extent permitted by law; have voluntarily read and understood this warning and accept
- and assume the inherent risks in participating in the Event.
